ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

Final Offer Price and Net Proceeds

- The final Offer Price has been determined at HK\$0.63 per Offer Share (excluding brokerage of 1.0%, SFC transaction levy of 0.0027% and the Stock Exchange trading fee of 0.005%).
- Based on the final Offer Price of HK\$0.63 per Share, the net proceeds of the Share Offer to be received by the Company after deducting underwriting fees and estimated expenses payable by the Company in connection with the Share Offer, is estimated to be approximately HK\$27.5 million. The Company intends to apply such net proceeds in the manner set out in the paragraph “Final Offer Price and Net Proceeds” below in this announcement.

Applications under the Public Offer

- The Offer Shares initially offered under the Public Offer have been very significantly over-subscribed. A total of 14,199 valid applications have been received pursuant to the Public Offer for a total of 2,924,072,000 Public Offer Shares, representing approximately 365.51 times of the 8,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- Due to the very significant over-subscription (by more than 100 times) in the Public Offer, the reallocation procedures as described in the section “Structure and Conditions of the Share Offer — Public Offer — Reallocation” in the Prospectus have been applied and the final number of Offer Shares under the Public Offer has been increased to 40,000,000 Offer Shares, representing 50% of the Offer Shares initially available under the Share Offer.

Placing and the Offer Size Adjustment Option

- The Offer Shares initially offered under the Placing have been moderately over-subscribed. The final number of Offer Shares under the Placing is 40,000,000 Shares, representing 50% of the Offer Shares initially available under the Share Offer.
- A total of 67 placees have been allotted one board lot of Offer Shares, representing approximately 32.06% of the total number of placees under the Placing. The total of 268,000 Offer Shares allotted to these 67 placees who have each been allotted one board lot of Offer Shares represent approximately 0.67% of the final number of Offer Shares under the Placing after reallocation.
- The Offer Size Adjustment Option has not been exercised by the Joint Bookrunners (for themselves and on behalf of the Placing Underwriters) and has lapsed.

The final Offer Price has been determined at HK\$0.63 per Offer Share (exclusive of brokerage of 1.0%, the SFC transaction levy of 0.0027% and the Stock Exchange trading fee of 0.005%).

Based on the final Offer Price of HK\$0.63 per Share, the net proceeds of the Share Offer to be received by the Company after deducting underwriting fees and estimated expenses payable by the Company in connection with the Share Offer (the “**Net Proceeds**”), is estimated to be approximately HK\$27.5 million.

The Group intends to apply the Net Proceeds as follows:

- approximately 10.9% of the Net Proceeds, or approximately HK\$3.0 million will be applied for the settlement of part of the setting up and opening costs of Paper Moon Restaurant under the sub-licensed Italian brand in Hong Kong;
- approximately 29.8% of the Net Proceeds, or approximately HK\$8.2 million will be applied for the set up and opening of a restaurant under Modern Shanghai brand in Hong Kong;
- approximately 41.5% of the Net Proceeds, or approximately HK\$11.4 million will be applied for the set up and opening of one restaurant under a refined Ta-ke brand in Hong Kong;

Two applications have been rejected due to bounced cheques. No invalid application which has not been completed in accordance with the instructions on the Application Forms, 22 multiple applications or suspected multiple applications, and no application for more than 8,000,000 Public Offer Shares (being the number of Public Offer Shares initially available under the Public Offer) have been identified and rejected.

Due to the very significant over-subscription (by more than 100 times) in the Public Offer, the reallocation procedures as described in the section “Structure and Conditions of the Share Offer — Public Offer — Reallocation” in the Prospectus have been applied and the final number of Offer Shares under the Public Offer has been increased to 40,000,000 Offer Shares, representing 50% of the Offer Shares available under the Share Offer.

PLACING AND OFFER SIZE ADJUSTMENT OPTION

The Placing Shares initially offered under the Placing have been moderately over-subscribed, which is equivalent to approximately 3.62 times of the total number of 72,000,000 Offer Shares initially available under the Placing. After reallocation to the Public Offer, the final number of Placing Shares allocated to 209 places under the Placing is 40,000,000 Placing Shares, representing 50% of the total number of Offer Shares available under the Share Offer.

In connection with the Share Offer, the Company has granted the Offer Size Adjustment Option to the Joint Bookrunners, exercisable by them (for themselves and) on behalf of the Placing Underwriters at any time from the date of the Placing Underwriting Agreement until 5:00 p.m. on Friday, 1 December 2017, to require the Company to issue and allot up to an aggregate of 12,000,000 additional Shares at the Offer Price to cover over-allocations in the Placing, if any.
